**Eye contact** : Flush with copious quantities of water. If irritation persists, obtain medical advice.

- Delayed and immediate effects and also chronic effects from short and long term exposure** : Carcinogenicity: Not listed as carcinogen by IARC, NTP, ACGIH, or OSHA. No incidence of carcinogenesis was evident in rat studies.  
  
Teratogenicity/Reproductive Toxicity: A. There are no adequate and well-controlled studies of trazodone use in pregnant women. Congenital anomalies and fetal resorption were reported in animals receiving doses up to 50 times those used in humans.  
  
Mutagenicity: Trazodone has clastogenic, mutagenic, and cytotoxic effects on human lymphocytes in vitro.
